#### Issues

- Challenged with two issues
  - (1) There is a high degree of artifact overlap (e.g. organization, role, etc.) across standards where same terms mean different things (homonyms)
  - (2) High degree of small models can make vendor adoption a challenge
  - We will start using a semantics tool (from Donald Chapin) by June to help alleviate this issue within BAWG
  - Someone at OMG needs to address this at a cross-standards level
