# Mission:

# Why A Multi-Lateral Approach?

- ❖ Electronic business interoperability is amazingly complex. It requires many decisions at many levels.
- ❖ It is unrealistic for any single group or standards body make all the decisions.
- ❖ Certain agreements/information sharing might best be made on ‘neutral turf’

# Why A Multi-Lateral Approach?

## Practical Considerations:

- There are many benefits to informal information exchange between industry groups – however, there are many meetings and not sufficient time and budget to get to every meeting

# Why Now?

- ❖ Cup half-full or cup-half empty:
  - Unique opportunity for dramatic interoperability gains by bringing together important work produced by different groups
  - Avert a crisis in electronic business
