

**OBJECT MANAGEMENT GROUP, INC. (OMG)
CONFERENCE EXHIBITION AGREEMENT**

You (the organization signing below) have requested exhibit space at the 4th Annual SOA in Healthcare Conference in Washington, D.C., USA on July 14th, 2011 (the Meeting) to exhibit your products and/or services. OMG is willing to allow you to conduct such an exhibition, on the following terms and conditions:

1. Table-top exhibit space is available to OMG members and non-members for US\$1,000.00 (this charge does not apply to workshop sponsors). You will be responsible for your own costs relating to the exhibition of your products.
2. OMG will provide the following:
 - An exhibit area consisting of a 6' table skirted with linens. A power strip and extension cord will be provided for electrical outlet access.
 - Your logo on exhibit area signage and exhibit participants' listing.
 - Passes and lunch for up to two exhibit attendants.
 - Additional attendants may register and pay to attend the workshop or pay an exhibit attendant fee of US\$250.00.
3. Your written request for space, and your logo in the appropriate electronic format (*.gif or .jpeg*), must be received by OMG at least *14 days* before the beginning of the Meeting. In the absence of your logo, your company name will be used.
4. OMG will allocate space to exhibit your products at the Meeting, subject to availability. The amount of space allocated to you will be based upon available resources and the number of written requests for space, on a first come, first served order.
5. You must have at least one employee present during the exhibit area's operating hours and to provide security for your property. You are responsible for all of your personnel; they will not be considered employees, agents or subcontractors of OMG for any purpose whatsoever. The use and storage of your property is at your sole risk. OMG does not provide any security. While at the Meeting, your personnel will be subject to the general rules and regulations of the Meeting.
6. OMG may prohibit the exhibition or display of any materials or products, or the manner of exhibition or display of any materials and products that OMG reasonably considers objectionable.
7. You agree to indemnify and hold OMG harmless from any liabilities, claims or demands (including related costs, expenses, and attorneys' fees) arising from or relating to your use of the demonstration space. OMG agrees to notify you of any written claims or demands made against OMG for which you are liable hereunder. This provision will remain in full force and effect after the expiration of the Contract Period.
8. **LIMITED WARRANTY.** THE EXHIBITION SPACE IS PROVIDED AS IS, AND OMG HAS NO LIABILITY IN CONTRACT, TORT, NEGLIGENCE OR OTHERWISE ARISING OUT OF THIS AGREEMENT OR THE USE

OF THE EXHIBITION SPACE. OMG MAKES NO EXPRESS OR IMPLIED WARRANTY WITH RESPECT TO THE EXHIBITION SPACE, INCLUDING WITHOUT LIMITATION, ANY WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE. IN NO EVENT WILL OMG BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY DAMAGES ARISING FROM OR RELATING TO THIS AGREEMENT, INCLUDING, WITHOUT LIMITATION, ANY PERSONAL INJURY, DIRECT, INDIRECT, SPECIAL OR CONSEQUENTIAL DAMAGES OR SIMILAR DAMAGES, INCLUDING LOST PROFITS, EVEN IF OMG HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES. YOU WAIVE ANY AND ALL CLAIMS THAT YOU MAY HAVE AGAINST OMG AND ANY DIRECTOR, OFFICER, EMPLOYEE OR AGENT ARISING OUT OF THE USE OF THE EXHIBITION SPACE.

9. This agreement contains the entire agreement between you and OMG and will be governed by and construed in accordance with the substantive laws of the Commonwealth of Massachusetts, excluding its conflict of laws and choice of law rules, and jurisdiction over any action to enforce this agreement, or any dispute arising from or relating to this Agreement, will exist solely in the state and/or federal courts located within the Commonwealth of Massachusetts.
