### **RECAP OF TECHNOLOY ADOPTED**

At the Object Management Group® TC meeting held from Dec. 5-9 in Coronado, CA, USA, the OMG® Board of Directors voted to adopt the FIBO® Business Entities 1.1 standard to define financial industry terms, definitions and synonyms for legal and business entities that may open an account, take out a loan, or participate in any public or private offering of securities or other business activities that require financial services. Like all FIBO standards, it promotes unambiguous shared meaning that helps the financial industry comply with new and future regulatory policies on how to manage risk.
