## It's Time to Define Standards for Artificial Intelligence

The time has come to define standards in artificial intelligence (AI). Such standards will greatly accelerate and improve the creation of useful AI applications by reducing the amount of low-level interchange, integration, or interfacing work currently required.

Object Management Group<sup>®</sup> (OMG<sup>®</sup>) has established an initiative in AI standardization. OMG is the best place for industry, academia, government and non-profit organizations to come together to define such standards because of its seminal work in knowledge representations, ontology and robotics, as well as the best practices in standards creation it has developed over the last 30 years.

### **OMG AI Standards Strategy**

The OMG AI strategy is based on three beliefs:

- Since the renaissance of AI at the beginning of the millennium, an expanded scope of AI has emerged. AI now reaches into many domains and integrates new technologies such as ontologies, vision recognition, analytics and machine learning for the industrial IoT, and more.
- When a technology area reaches a certain degree of maturity, standards can enable innovation by freeing organizations from having to constantly worry about the "plumbing" of systems or re-inventing platform techniques and tools.
- OMG is uniquely placed to lead this effort because it has a proven process; it has developed a series of foundational capabilities that can bootstrap the effort; and it covers many industry domains that can benefit from AI standards.

Al has matured and its successful application can be enhanced by the development and adoption of standards. OMG has the capability and motivation to successfully expand its activities in this domain.
