Why Should You Become a Certified Expert in BPM (OCEB 2)?

- Credentials are important in the BPM world, where practitioners may work on many projects for different clients or employers over time.
- Designed by twenty-five experts from top BPM companies and well-known independent consultants, the OCEB program's topical coverage lets prospective employers feel confident about a certified candidate's abiity to participate in or lead real-world initiatives in enterprise BPM.
- Your status as an OCEB 2 Certified Professional shows that you have required knowledge and skills, making you a more attractive candidate for hiring and promotion.
- OCEB 2 tests not only a candidate's knowledge of the domain's standards (such as BPMN[™], BMM[™], and BPMM[™]), but also aspects of the application of those standards in the field, and of industry best practices, over a wide range of process-related topics.

OCEB 2 Exam Levels:

The OCEB[™] program consists of five examinations, granting five Certifications. Above the single Fundamental level, the program splits into two tracks one business-oriented, the other technically-oriented.

FUNDAMENTAL

A productive member ranked in the top half of his or her BPM project team should have the knowledge and skills to acquire this certification.

BUSINESS INTERMEDIATE

A BPM Team Lead on the business side, discovering, modeling, and analyzing business processes, should have the knowledge and skills to acquire this certification.

TECHNICAL INTERMEDIATE

A BPM implementation team lead, implementing and maintaining BPM systems, should have the knowledge and skills to acquire this certification.

BUSINESS ADVANCED

A BPM consultant to high-level management, or practitioner responsible for BPM scope and direction at Director level in an enterprise, should have the broad knowledge and skills covered in this certification.

TECHNICAL ADVANCED

A BPM consultant to high-level management working on the technical side, or BPM practitioner responsible for process performance and governance in an enterprise, should have the broad knowledge and skills covered in this certification.
